



ZoneTrol II™ AZ-1A Zone Pump Controller



DESCRIPTION

The ZoneTrol II AZ-1A pump controller can be field mounted to any B&G NRF, NBF, SSF or 1/12 to 1/6 HP Series PL™ booster pump. The AZ-1A controller operates the pump when the thermostat calls for heat. The controller can be wired to fire the boiler through a 24 volt rated isolated endswitch. The AZ-1A relay boxes can be daisy-chained to form up to a maximum of three zones. The AZ-1A pump controllers are UL and cUL listed. When the AZ-1A is mounted on a B&G pump, the pump and controller assembly maintains the UL listings.

CONSTRUCTION

The ZoneTrol II AZ-1A pump controllers are solidly constructed, easy to mount units featuring printed circuit board design and a powerful 2.5 VA transformer for operating up to three zones. An amber LED light on the PC board indicates a call for heat. The units are listed with Underwriters Laboratories, Inc.

TYPICAL SPECIFICATIONS

Single Zone (AZ-1A)

Furnish and install zone pump controller(s) as shown on plans. The controller(s) shall be UL and cUL listed and suitable for operation of a single circulator pump. Controller shall include a nominal 2.5 VA transformer, pre-wired printed circuit board that can be easily field mounted to Bell & Gossett pump model _____ [choose from NRF, NBF, SSF and Series PL boosters]. The pump controller shall have a 24-volt rated isolated endswitch to fire the boiler when there's a call for heat. An amber LED shall be on the PC board to indicate a call for heat. The pump controller must be rated for a full 5 amps and have a DPDT switching action. All models shall be Bell & Gossett Model AZ-1A. When the control is mounted to a single circulator pump, the pump/controller assembly will be UL listed.
